SUBJECT: MINUTES OF IMPLEMENTATION COMMITTEE MEETING HELD UNDER THE CHAIRPERSONSHIP OF DIRECTOR GENERAL, TOURISM ON 18.06.2019 AT 11:00AM

A meeting was held under the Chairpersonship of Director General, Tourism on 18.06.2019 at 11:00AM in the Manthan, 1stFloor, Transport Bhawan, New Delhi to discuss the factors affecting signing of MoUs under "ApniDharohar, ApniPehchaan- Adopt a Heritage" project of the Ministry of Tourism.

Director General (Tourism) welcomed all the officers & representatives present in the meeting and briefed them on the purpose of the meeting. A presentation was made by the PMC, Adopt a Heritage on the following agenda:

- i. Factors affecting signing of MoUs
- ii. Factors affecting MoUs at Implementation Stage
- iii. Way forward for the project.

A. The Committee then deliberated on following:

- 1. Semi-Commercial Activity: The committee took note of the challenges being faced by the MoT and ASI during the execution of the same in the MoU. The committee decided to put the clause before the next O&VC for approval and final decision.
- 2. Director General (Tourism) suggested that MoU to be sent to ASI after signing from MoT for consideration and approval. Post approval from ASI, the MoU to be sent to Monument Mitra for signing. The DG (T) also suggested that ASI should take the final call on the activities which they want to undertake at their site and remove the activities from the MoU on which ASI is not agreed.
- 3. ASI to communicate the nominated Nodal Officer for the Adopt a Heritage project.
- 4. The committee decided that the responsibility of raising the funds for the implementat ion of the project will be held with Monument Mitra. In lieu to this, the committee agreed to include the financial clause as a standard clause of the MoU, "Monument Mitra through its CSR/ other financial model including internal and external accruals, at no cost to the Government of India intends to take up the development of monument/site under the Adopt a Heritage project".
- 5. The committee agreed to the **Publicity and Awareness clause** that the "Ministry of Tourism, Ministry of Culture and Archaeological Survey of India / Asset Owner shall have the right to review within a reasonable period of time, before issuance of any advertisement, press release, or any other public statements with respect to the activities contemplated herein; the Ministry of Tourism, Ministry of Culture and Archaeological Survey of India / Asset Owner prior to press release / publication shall be provided with a copy thereof and be given a minimum of 7 (seven) days' time to comment, modify or restrict the publication of such advertisement, public statement or press release".
- 6. The committee agreed that the term "Amendment" may be used instead of "Addendum" for the various changes to be made in the existing MoU. Addendum may be considered for changing or revising the amenities proposed as part of the MoU Annexures.
- 7. The committee decided to call Indian Oil Foundation for meeting with Director General, Tourism and Director General, ASI for the sites Khajuraho, Mahabalipuram and Sun Temple, Konark to be considered under Adopt a Heritage project for development.
- 8. The committee decided that the Monument Mitra will submit monthly progress report for each site to all concerned parties in MoU with details on works executed and challenges faced during the implementation phase of the project.
- 9. The standardised format of the Memorandum of Understanding (MoU) will remain same through-out all the MoU's under Adopt a Heritage project only the Annexure will be dynamic.

10. The committee decided to conduct 9thO&VC meeting in the month of July, 2019.

B. Decision on sites –

- 1. **Jantar Mantar, Delhi** MoU to be sent to ASI for signing. ASI conveyed that they will allow Information Booklet only when no revenue generation activity taking place from the amenity.
- 2. **Sun Temple, Konark** The committee decided not to give the site to Dalmia as Indian Oil Foundation is already doing the work over there under the supervision of ASI.
- 3. **Udaygiri and Khandagiri Caves, Odisha** Letter to be sent to Dalmia to know their standing for these sites.
- 4. **Tomb of Adham Khan, Delhi** The committee was apprised that Bluebells School was selected as the Monument Mitra for the project. However, due to certain financial conditions, the Monument Mitra is keen to take up the site jointly with Bliss Inns Pvt. Ltd. (V Resorts) for the development of amenities. The committee decided that file to be put up approval.
- 5. **Ramappa Temple, Telangana**—The committee concluded that given the prospective Monument Mitra is a Trust and does not have much financial strength, the committee suggested that they may generate the funds from different sources at no cost to the Government of India under the project. O&VC was also agreed and apprised with the Kakatiya Heritage Trust financial condition. MoU to be sent to ASI for finalization and signing.
- 6. **Khajuraho ,Madhya Pradesh** Vision Bid prepared for Khajuraho Eastern Group of Temples, MP by M/s Dalmia Bharat to be put up before O&VC for approval.
- 7. **Hampi, Karnataka** ASI was asked to look after the implementation work of signage at Hampi site in Karnataka taken up by the Monument Mitra (Yatra Online Pvt. Ltd.). Secretary (Tourism), Karnataka and HWAMA will provide assistance for the execution of the same. Meeting to be called for all Hampi sites with Monument Mitras, Iconic site consultant, ASI and all other concerned stakeholders.
- 8. **Gandikota Fort, Andhra Pradesh** –ASI has agreed for setting up of Duty Shed to prevent vandalism at site. M/s Dalmia Bharat to initiate the process of fabrication of the same. Implementation Committee decided to conduct site visit in 2nd week of July, 2019.
- 9. **Purana Quila, Delhi** ASI to take final decision for the site to be incorporated under Adopt a Heritage project.

10. **Gwalior Fort, Madhya Pradesh** – ASI agreed to move MoU for approval. PMC to share the Madhya Pradesh Tourism Department letter regarding their approval to the vision bid document for Gwalior Fort, Madhya Pradesh submitted by Gwalior Heritage Foundation.
